



IMPORTANT INFORMATION REGARDING COVID-19 (Step 3)

Select City of Brampton Recreation Centres have reopened for limited and modified programs and services, including permitted use of indoor and outdoor sports amenities. Please review important information pertaining to permitted use of City facilities:

- In accordance with Ontario regulations and Ministry Guidelines, proof of vaccination requirements apply for patrons visiting City of Brampton Recreation facilities beginning September 22, 2021.
- Permit holder is responsible to ensure all participants complete pre-activity health screening in accordance with Peel Public Health requirements.
- Permit holder is responsible to ensure that an accurate list of all participants is compiled upon each visit for contact tracing purposes. This list is to be made available to the City of Brampton if needed.
- Sports leagues must have prepared their own Safety Plans.
- All participants are to follow recommended Peel Public Health hygiene practices while on site.
- All participants are to arrive no more than 20 minutes prior to their indicated permit start time and should exit within the following 20 minutes after their permit end time. This is to avoid crossover of groups and allow for cleaning.
- Please be advised that there is no loitering permitted in facilities or in facility parking lots. Participants should arrive and enter/exit as a group.
- Indoor and outdoor gameplay is permitted at this time.
- While indoors, masks are to be worn by everyone at all times except those currently participating in physical sport activity.
- Outdoor sport facilities with spectators permitted at 75 per cent capacity or up to 15,000 people – standing, or 30,000 people – seated, whichever is less.
- Indoor sport facilities with spectators permitted at 50 per cent capacity or up to 10,000 people, whichever is less.
- Spectators to be approved and managed by the permit holder.
- Masks are required for indoor spectators at all times.
- Every outdoor spectator must wear a mask unless they are seated with members of their own household and seated at least two metres from every person outside their household. All are expected to maintain physical distancing.
- All groups must follow current Ontario provincial guidelines with respect to gathering restrictions and vaccine requirements, as well as any other PSO/NSO guidelines.
- Locker rooms/dressing rooms and showers available at select locations.
- All participants are to follow any specified facility traffic flow plans.

Any violation of these guidelines and policies will result in the revocation of your permit and may effect future bookings with the City of Brampton.
